## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease **per capita** over the next five years to **1.36** tCO<sub>2</sub>e by end of March 2028. This is a reduction of **10%**

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since 2023. The carbon emission reduction achieved by these schemes equate to **0** tCO<sub>2</sub>e, a **zero%** reduction against the 2023 baseline and the measures will be in effect when performing the contract:

*Launch of an Environment Policy*

*CO<sub>2</sub> off-setting via the Woodland Fund Scheme operated by Carbon Neutral Britain – This equates to **126.60** tCO<sub>2</sub>e, **100%** of the 2023 emissions*

*Individual pledges by staff at the All-Company Meeting to reduce CO<sub>2</sub> emissions.*

In the future we hope to implement further measures such as:

*Work with Carbon Neutral Britain (using 2024 as a baseline) to reduce our carbon dioxide emissions and continue to offset the remainder using high quality (UN accredited) offsetting schemes*

## Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
